Directors appointed by ANZ need to be conscious of the possibility of a conflict between the interests or duties owed to the Members and the interests of ANZ. To the extent of conflict in exercising their powers as a Director, they must prefer the interests of Members.</li> </ul>
Directors and Responsible Persons	<ul style="list-style-type: none"> <li>• Receipt of gifts, rewards, entertainment or sponsored travel valued at over \$500 or where it could create any obligation or expectation that could conflict with their role as an officer of the Trustee. The provisions in relation to accepting gifts or hospitality from such entities are set out in the Code of Conduct in the Corporate Governance Statement.</li> </ul>

Scheme Administrator	<ul style="list-style-type: none"><li>• The Scheme Administrator (Australian Administration Services Pty Ltd) provides superannuation administration services for the Scheme and MUFG Retire360 Pty Ltd (formerly Link Advice Pty Ltd) has been engaged to provide Scheme members with general or limited personal financial advice about options available within ANZ Staff Super. The Scheme Administrator is part of the MUFG group, which offers a range of financial and other services. While the services of the wider group would not be expected to give rise to conflicts of interest, care needs to be taken to consider the potential for conflicts in relation to the group's other commercial interests when providing services to the Scheme.</li></ul>
Asset Consultant	<ul style="list-style-type: none"><li>• WTW provides asset consulting advice to the Scheme. In providing this advice, it may put forward for the Trustee's consideration investment opportunities in which it has a commercial interest. Before investing in such options, any potential conflicts of interest will be reviewed and independent advice and due diligence sought before investing in such options.</li></ul>
